Acceptable forms of payment are:

3. PayPal (will accept credit cards, there is a 4% charge to the buyer if you chose to use PayPal)
4. Western Union or Wal-mart Money gram

Puppies and shipping will need to be paid in full, no later than Monday of the week they are to ship. No puppy will leave us before the age of 8 weeks. Some puppies may require a few more weeks to mature to be able to arrive safely at its new home.

Thank you for purchasing your new puppy from Big Holler Pups. We have done our very best to insure that your puppy comes to you healthy and happy. Puppies are raised in a safe, loving environment. Every puppy is unique in appearance, personality, size, etc. Placing puppies into loving forever homes, and making that transition as smooth as possible for the puppy and you is our goal.

At the time of leaving for their new home, each puppy is current on vaccinations and wormings. A written record of this will be provided with every puppy. Puppies are in good physical and emotional health. Each puppy has had comprehensive health exam from our vet, and has been issued a health certificate before shipping.

We are anxious for your new furbaby to meet your vet. You will need to have this done within 72 hours of your puppy's arrival. Once you know the date your baby is arriving go ahead and schedule an appointment. Buyer will send written proof of veterinarian's exam within 10 days. Please document

your puppy's micro chip number on **ALL** records.

Buyer agrees to provide puppy with routine preventative care, such as, but not limited to:

1. Annual physical exam by a licensed veterinarian.
2. Follow vet's guidelines for, shots, deworming, heartworms, and flea and tick preventative.
3. Provide adequate housing, food, and water.
4. Do not allow your new puppy to run loose and unattended.
5. Do not take your new puppy to a public dog area, (pet store, dog park, etc.) until all puppy shots have been completed. (Usually around 4 months of age).
6. Feed your new baby a high quality dog food, not human food. We recommend vitamin supplements of NU VET PLUS; please use our number # when ordering.
7. Most importantly, give your new baby lots of love and attention.

If by the puppies first birthday a licensed veterinarian discovers a congenital defect that will interfere with the normal life function or health of the puppy, buyer is to notify seller immediately. Upon written documentation for our veterinarian to review, if he agrees with buyer's veterinarian, a replacement puppy will be made available as soon as a puppy of equal quality and gender becomes available. Registration papers must be returned prior to replacement. All veterinarian and shipping costs will be paid by the buyer. Seller does not guarantee this puppy can be shown or bred. Breeding of this dog will make this guarantee null and void. Seller does not guarantee on: size, weight, color, coat, height, etc. Seller will not be responsible for any medical expenses incurred. This guarantee does not include, injuries, hernias, cherry eye, stenotic nares, inverted tail or vulva, coccidia, giardia, parasites, loose hips, allergies, infertility, or kennel cough.

Buyer is aware that owning a puppy means trips to the veterinarian and understands that he/she is responsible for all bills incurred.

This Guarantee is not transferable and is only valid for the original buyer.

Buyer agrees that he/she understands fully and that this contract is under the jurisdiction of the state of Missouri, county of Texas, and that the place of venue shall be Texas County, Missouri.
